RDS Blog: Qualitative Research and PPI – Some similarities, quite a lot of differences!

Have you ever wondered, or been asked, about the differences between patient and public involvement (PPI) activities and qualitative research? Both aim to include patients and the wider public in research which is relevant to their lives and experiences. Some assume that conducting either PPI or qualitative research negates the need for the other.

This is not true, both PPI and qualitative research uniquely add to and augment the research process, bi-directionally complementing and influencing one another.
